WHEREAS, Forest County has lands enrolled in the County Forest Law Program, pursuant to ss. 28.11 of the Wisconsin Statutes, commonly referred to as the Forest County Forest; and

WHEREAS, the Forest County Board of Supervisors on April 7, 2007, adopted Resolution #07-2007 approving the Forest County Comprehensive Land-Use Plan for a period encompassing 2006-2020; and

WHEREAS, the Forest County Forestry and Recreation Committee, recommends accepting and approving the amended 2012 County Forest Boundary Map attached hereto; and

NOW, THEREFORE, BE IT RESOLVED that the Forest County Board of Supervisors accept the recommendation of the Forestry and Recreation Committee and hereby accepts and approves the 2012 County Forest Boundary Map; and

BE IT FURTHER RESOLVED that Chapter 900 of the 15 Year Comprehensive Land-Use Plan 2006-2020 be amended to include the 2012 County Forest Boundary Map as set forth in Chapter 900, page 900.3; and

BE IT FURTHER RESOLVED that the Forestry and Recreation Committee is directed to forward said amendment to the Wisconsin Department of Natural Resources for their approval.
